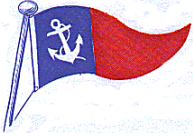


Satuit Boat Club

Rules and Process of Admission to Satuit Boat Club

(Please read carefully before submitting application)

1. To ensure action on your application for Provisional Membership, it must be filled out completely.
2. Application for Membership must be accompanied by letters from two sponsors that are Regular SBC member or Life Time SBC member currently in good standing.
3. Sponsorship letters must be sent directly to the SBC Secretary either by mail, email or handed directly.
4. Full completed applications with sponsorship letters will only be considered.
5. Applicants must request a copy from one of their sponsors and familiarize themselves with the rules and constitution of the club.
6. Two checks must accompany the applications, one for the current annual dues and a second for the one time initiation fee. Note checks will not be cashed until membership is approved. Check will be returned for applicants not approved.

Provisional Membership

All new members enter as Provisional Members. Provisional Members are subject to the same rules and constitutional provisions as full time members. Additional special conditions do apply to Provisional Members.

A Provisional Member may apply in writing to the Secretary for Regular Membership after payment of one year's dues and attending 3 regular meetings during the first year. Failing to apply or be accepted as a Regular Member will revert to Provisional Membership for one additional year at which time the Member must apply for Regular membership. Failing to apply after two years will result in termination of membership.

Provisional Members:

- Have the right to one vote and have full use of the facilities of the club.
- Are allowed guests when accompanied by the Provisional Member.
- Shall not have the right to sponsor or hold office.
- Must attend at least three regular meeting within the 1st year.
- Shall be required to participate in two work parties per year.
- Must serve on one of the SBC committees during the first 2 years of membership.

Sponsorship Recommendation Requirements

- How the Sponsor knows the Applicant (business, socially, etc.)
- Why the Applicant would be a good addition to the Satuit Boat Club.
